### **Call to Order**

Dr. Chung opened the meeting at 6:48pm and welcomed everyone. Dr. Chung started the meeting by reviewing the suggestions cards from the previous meeting. We discussed lecture topics that would be interesting for General Dentist's and decided we will try to focus on topics like oral pathology and restorative Dentistry next year.
